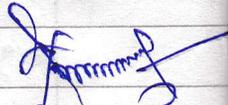
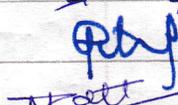


Notice

Coming to the second agenda of meeting, planning for the anti-ragging cell activities in the college.
