Rules and Regulations for conducting Courses Under

# Jeevan Shikshan Abhiyan (Skill Based & Need Based Courses)

### on No Grant Basis

 The Short Term Certificate Courses under Jeevan Shikshan Abhiyan will be conducted under the jurisdiction of Rashtrasant Tukadoji Maharaj Nagpur University.

 The College/Institutions affiliated to Rashtrasant Tukadoji Maharaj Nagpur University may be granted permission to conduct Short Term Certificate Courses approved by the Department of Lifelong Learning & Extension under Jeevan Shikshan Abhiyan.

3. For conducting the courses, the college/Institute will have to submit a proposal to the Director (LLE) in the prescribed proforma.

4. The College may also formulate their own 'Need Based' Courses under Jeevan Shikshan Abhiyan.

The syllabi may be prepared by the Colleges on their own by involving subject experts and the benefits of this courses can be extended to the interested individuals of any age group.

5. The proposal submitted by the college will be scrutinized and recommended for approval (if in line) by the committee of exports constituted by the Director, Department of Lifelong Learning & Extension

6. The Institute/college should make available services of qualified and trained staff available for teaching either from their institute or from the same domain working in Industry/Institute/Organization.

7. Proposals received from the colleges/Institutes will be submitted to the Board of Lifelong Learning & Extension and if required, Hon'ble Vice-Chancellor can approve the proposal on behalf of the Board and then it will be placed before the Board for post facto approval.

8. The fees for each course will be proposed by the College and put it for approval. Board of Lifelong Learning & Extension will be the final authority to finalize the fees for each course which can be modified from time to time with justification. 10% of the total fees will have to be deposited with the Department of Lifelong Learning & Extension as Registration Fees per student along with the names of students admitted.

A Proposal fee of Rs. 500/- for Certificate Course will have to be deposited along with the proposal in the Department of Lifelong Learning & Extension, Rashtrasant Tukadoji Maharaj Nagnur University.

9. Amount should be deposited with the Department as Registration Fees within 15 days from the date of commencement of the course by <u>DEMAND DRAFT/NEFT/RTGS</u> in favor of "Director Department of Lifelong Learning & Extension, RTM Nagpur University". (Account Details: DEPT OF LIFELONG LEARNING & EXTN RTMNU, A/c No. 876220110000073, IFSC: BKID0008762, BANK OF INDIA, RTM NAGPUR UNIVERSITY BRANCH, NAGPUR-440033).

10. The intake capacity of candidates will be decided by the Board of LLE.

11. Colleges should maintain an account of the fees collected from the students and the expenditure incurred throughout the length of period of the course.

12. Course should be started within a month from the date of issue of sanction letter, otherwise the sanction will be treated as cancelled. If the College cannot start the course within one month, the same should be informed to the Director of LLE office with proper justification.

13. Immediately after the course is over, the audited accounts along with the report including geotagged photo/ screenshots of the course should be submitted to this Department.

14. If college runs the course, Principal should nominate a Course Coordinator from amongst the staff members. While appointing the Course Coordinator knowledge and experience etc. should be considered for the relevant course to be conducted under Jeevan Shikshan Abhivan.

20. The Duration and Total fees for these courses may not exceed the following limits.
