He inaugurated the seminar and began his speech by saying that "Intellectual property is now the most important property in the modern times." He differentiated between immovable and immovable properties. Giving examples he described the difference between tangible and intangible types of property. He also touched upon issues of geographical space, patents, copyrights etc.
